They enjoy the same rights and duties except for the reserve: the right to vote for the senate, amendment of statutes, dissolution.

The candidate acknowledges that before enthronement into the respective order degree, a one-time seal fee is collected and an annual obolus is raised to achieve the orde objectives. I have been informed about both amounts. I acknowledge that to settle the one-time seal fee and the current annual obolus, signing a direct debit authorization (bank transfer) is required. I will immediately return this signed, supplemented with the account number and the banking institution, to the Senate Office.
